## Are you getting ready to PCS?

Please remember we require a minimum 30-day written Notice to Vacate.

If you have been notified that you will be leaving us please make sure to send us an email to

laughlin@huntcompanies.com with your address, name, and preferred date for your pre and final inspections. Your RSS will then reach out to schedule your inspections and to explain the electronic Notice to Vacate packet via DocuSign. Pre-inspections are completed at least 21 days before your move out, if possible to give ample time for planning. Your Final is scheduled when your home is empty and you are ready to give us the keys. You will need to clear with us before you can be removed from MPF or your meeting with Career Development.

You **DO NOT** need orders to give us notice, but you will need them before your final inspection. If you are unsure of your departure date make sure to tell your RSS your dates are tentative. If you have already received orders you can either attach them to the Notice to Vacate or bring them to our office.

Please note you are still responsible for the full 30 days even if you decide to move out sooner and do not have short notice orders.
